Extended Care Hours

Before Care

7:15 AM - 7:50 AM

After Care

Full Days 3:15 PM - 6:00 PM Half Days 12:05 PM - 6:00 PM

A late fee of \$20 will be charged for each 15-minute interval or any part thereof after 6:00 PM. This account must be kept current.

Approved Pick Up List: Approved pick up individuals must be entered into FACTS. Persons picking up students must be prepared to show an ID, and students will only be released to individuals entered into FACTS or for whom we have received written permission from parent/guardian.

Extended Care Discipline: Students in extended care will be expected to follow the expectations of SCS and the discipline concerns will be addressed in a similar manner as during the school day. Please see the Summit Family Handbook for more information.

Extended Care Rates

As-Needed Basis

In order to utilize our before and after care services on an as-needed basis, families must pay a \$25 enrollment fee. This will add your child(ren)'s name(s) to the before and after care lists.

Before Care- \$3/day

Parents must walk their child(ren) through the small playground to the third exterior door (first grade classroom).

After Care- \$5/hour

The after school care program uses the library with entry through the courtyard. The after school care program will also be offered on school days with an early dismissal.

Payment Plan (Discounted Rate, Must be Pre-Paid)

Discounts are available for families choosing to enroll in a payment plan. This charge is then added to the family's FACTS account monthly for nine months (July - April). This payment plan will reoccur each month unless a parent notifies the school in writing with his/ her desire to change the level of care needed. This is done so that we can ensure adequate coverage for extended care. The after school care program will also be offered on school days with an early dismissal.
